7. Narrative Description

This is a two story concrete block building with multiple apartments on the second story, and five office or business spaces on the first story. A shingled pent-roof canopy extends the full length of both the south and west facades above the first story spaces. The building was built in two phases. Originally, a one-story building was constructed with commercial spaces only. In 1978, the second story and pent-roof awning was added. Two commercial spaces face 2nd Street to the south. From west to east, there are two large single-light windows, a door to a small entry hall with two doors (one entering the west office and the other entering the east office), two more large single-light windows, and one additional entry for the east office space. The second story has a group of four vertical windows near the west corner, two pairs of two vertical windows, and a group of three double hung windows at the east end. The west side faces Marion Ave, and it has two additional office spaces. Starting at the north (left) end of the facade, there is a single-light window, an entry to an office space, and set of three vertical windows, a door providing access to the second floor apartments, a large single-light window, and then two larger single-light windows. The second story has a group of three double-hung windows at the left, a set of three vertical windows in the middle, and a set of four vertical windows at the right.

8. Narrative Statement of Significance

Though the original construction of the Gloyer Building falls among other buildings constructed in the Washington Downtown Historic District in the 1950s and 1960s, the current appearance resulted with the second story addition in 1978, and the integrity dates to this period. Thus, this building is counted as non-contributing as falling after the period of significance for the historic district.

William Scofield sold the south half of Lot 5 and south half of the west 44 feet of Lot 6 to Carlton C. Wilson on October 23, 1916. On February 3, 1917, Wilson sold the same property to Ralph Dougherty. He operated a clothing store, Dougherty Brothers, on the west side of the square, and he was married to the daughter of Winfield Smouse, real estate developer. It appears that he built the corner gas station here at the corner at 202 N. Marion, as well as the two-story building to the east at 114-116 W. 2nd Street and the one-story building at 112 W. 2nd Street. The gas station is still shown here on the 1943 Sanborn map. Ed's Service Station is listed at 202 N. Marion in the 1952 city directory.

According to the assessor's records, the property was sold as a vacant lot in August 1956 to Raymond Gloyer, who continued to own it until 2008. The assessor then lists 1957 as the construction date for this property. The building included the 118, 120, and 122 storefronts along W. 2nd Street and the 202 and 204 storefronts on N. Marion. The 1964 city directory lists the office of Gloyer's Hatchery at 202 N. Marion and Easy-Wash Laundromat at 204 N. Marion. On the south side, Sellers Insurance is listed at 118 W. 2nd Street, the Credit Bureau and Western Union at 120 W. 2nd Street, and Dutch's Barber Shop at the corner at 122 W. 2nd Street.

Washington Evening Journal, 60th Anniversary Edition, February 27, 1953 - page 37 - Gloyer Hatchery and Feed - started as Washington Chick Company in 1947 - Ray Gloyer from Whiting, IA - first season in 1948 - Hy-Line breed - hatching 8,000-9,000 chicks per week - 116 ½ E. 3rd Street

A building permit was issued on April 5, 1978 to Ray Gloyer for this building to add one story for apartments for \$20,000. The 202 N. Marion address appears to have then been used for the apartments on the second story.

In 2008, the building transferred from the Gloyer family to Gloyer Apartments LLC. Currently the building is occupied by Kat's Grain (204 N. Marion), Child Advocacy Board (122 W. Second St.), Elaine's Beauty Salon (120 W. Second St.) and The Polished Image (118 W. Second St.).




Location map
