#### **Narrative Description**

This is a one story frame ranch house built around 1950 on the north side of W. Main Street. The house sits on a concrete block foundation, and the walls are clad in vinyl siding. The cross-gable roof is covered in asphalt shingles. The windows retain original horizontal two-over-two-light double-hung wood sashes and have storms/screens. A garage sits behind the house along the alley.

The façade (south elevation) is divided into three sections by a center projected cross-gable section. The left/west section includes a large picture window with an adjacent one-over-one-light double-hung window to the right. The left flanking window is found around the corner. The right (east) section has the entry with wooden shutters, and it has a small wood deck with a wood rail. The central section has a front gable with a set of three two-over-two-light double-hung offset to the right, with shutter to the left/west and an adjacent double-hung window on the east side of the projected section to the left.

The east elevation is composed of the gable side of the house, the side of a connecting passage, and the side of the rear room. The left/front/main section has an oriel window with center picture window and two-over-two-light double-hung windows on each of the angled sides of the oriel window. To the right (rear) of the bay window, there is a band of windows consisting of a large picture window with a narrow two-over-two-light double-hung window to either side, and a pair of horizontal two-over-two-light double-hung window to either side, and a pair of horizontal two-over-two-light double-hung window to the north. The center/passage section has entry with an aluminum door and two concrete steps. The right/rear/north section has two horizontal two-over-two-light double-hung wood windows with wood shutters.

The west elevation is similarly composed, with the side of the main section of the house on the right/south and the side of the rear extension on the left (setback toward the east side). The right/main/south section has a horizontal two-over-two-light double-hung wood window at each corner, adjacent to windows around the corner. A third horizontal two-over-two-light double-hung wood window is roughly centered on the wall The left/rear section (rear) has two horizontal two-over-two-light double-hung wood windows with wood shutters. The central/passage section has an entry with an aluminum door.

The north elevation has three sections, with the main house split by the rear extension. The left/east section (main section of house) has picture window and a horizontal two-over-two-light double-hung wood windows that continues the band from around the corner. The center section (rear extension) has two horizontal two-over-two-light double-hung wood windows at each corner with wood shutters on the inside side. They likewise are paired with windows around each corner. The right/west section (main section of the house) has a set of three horizontal two-over-two-light double-hung wood windows on the left/east and a single one-over-one-light double-hung window with wooden shutters on the right/west. A concrete patio extends from the northwest corner of the house to the west side of the rear extension and is surrounded by a wooden fence.

A single-car frame garage constructed in 1960 per the assessor sits in the northwest corner of the property. It is clad in wood siding and sits on a concrete foundation. The gable roof is covered in asphalt shingles.

#### Narrative Statement of Significance

The Lucy Dempsey House appears to contribute historically and architecturally to the potential residential historic district on the west side of Washington. The ranch house was built during the post-World War II development of the neighborhood when a number of similar houses were built, and it is significant within this period of later development of the neighborhood. The period of significance for the historic district is anticipated to extend through 1965, so it would fall within this period. The house retains a number of original features characteristic of houses in this period, particularly the horizontal two-over-two-light double-hung wood windows and windows placed at corners

This house does not appear eligible for individual listing on the National Register of Historic Places under Criteria A, B, or C. The house does not appear to have particular historic or architectural significance individually.

### History / research summary of property

This parcel (west ½ of Lot 7 and east half of Lot 8) was owned as part of the property to the west from 1870 to 1950. On March 20, 1950, Leonard T. and Mary A. McKeone transferred this part of the property to the estate of Mary Dempsey through her executor Lucy Dempsey. The assessor lists a construction date of 1950. Lucy Dempsey then appears to have built a house on this parcel, and the address is first listed here in the 1952 city directory with Lucy Dempsey as resident. The 1954 directory also lists her sisters Alice, Cecile, and Bertha Dempsey. According to her March 24, 1978 obituary, Lucy was a lifelong resident of Washington and was described as a longtime secretary of the National Bank of Washington until her retirement in 1963. According to her November 30, 1970 obituary, Alice lived and worked in Omaha before returning to Washington. According to her November 19, 1975 obituary, Bertha did charity work in Cedar Rapids and St. Louis before returning to Washington and working at McCleery-Cummings and Co. Kathryn Dempsey and Nell Dempsey had both moved to 610 W. Main by 1956 according to the city directory. According to her November 14, 1972 obituary, Nell worked as a secretary in Omaha before returning to Washington after her retirement in 1954. According to her November 6, 1982 obituary, Kathryn was a teacher in Sioux City and Pisgah before returning to Washington. Directories through the 1960s and 1970s list the sisters living here through their retirements until their deaths.

The estates of Lucy and Kathryn Dempsey sold the property to Michael J. and Judy A Redlinger in October 1978.



### Location map




2009 aerial photograph (Washington County) – line indicates survey/research area boundary
