#### **Narrative Description**

This is a two story frame Queen Anne house located on the southwest corner of the intersection of W. Washington Street and South Avenue F. Sunset Park is located immediately to the west of this property, established in the early 1900s. The house sits on a stone foundation, and it is clad with vinyl siding. The windows are vinyl replacements, and some have shutters. All the windows have aluminum storm /screens. There is a basement level attached garage at the northwest corner of the house, and a one story frame addition at the southwest corner of the house.

The facade, the east elevation, is divided into with a two-story bay window on the left/south and the main section of the house on the right/north. The façade has a wrap around porch which begins at the bay window and continues around the northeast corner past the entry door to the east side of the north able-roof wing of the house. The porch has wood steps leading up to the corner of the porch at a 45° angle from an angled sidewalk from the steps at the corner of the property. The porch floor is wood, and the railings are vinyl. There is a gable-roof pediment over the steps with beadboard on the gable. The hip roof of the porch is clad in asphalt shingles. The entry sits on a chamfered northeast corner of the house at a 45° angle to the house and faces the steps / corner of the property. The historic wood door has a window in the top half of the door, with decorative wood carving and two wood panels below the window. There is a single light aluminum storm / screen door. To the left of the entry door, facing east, there is a one-over-one-light double-hung vinyl window, and to the left of the entry door, facing north, there is another one-over-one-light double-hung vinyl window on the first story. At the far right side of the porch where it meets the east wall of the north gable-roof window, there is a third one-overone-light double-hung vinyl window with a lower sill than the other two porch windows on the east wall of the north wing. A one-over-one-light double-hung vinyl window is found on the second story above this window also. There is a two-story bay window on the left/south half of the facade. It has a large single-light fixed window on the center wall of the first story and a one-over-one-light double-hung vinyl window with shutters on the center wall of the second story. The angled walls of the bay window have one-over-one-light double-hung vinyl windows on both the first and second stories. The gable overhangs the angled walls of the bay window, supported by decorative brackets. There is a window size attic vent centered in the gable. The second story of the facade, to the right/north of the bay window, has a one-over-one-light double-hung vinyl window with shutters.

The north elevation is divided into three sections, the side of the main/east section of the house, the gable-roof north wing, and the north side of the one-story rear section. The north side of the east section was described with the porch, with a window on the first story and no windows on the second story. The center gable-roof section extends north from the main form of the house. It has a one-over-one-light double-hung vinyl window centered on the first story. Above it, on the second story, there is a one-over-one-light double-hung vinyl window with shutters. The gable retains an original decorative wood windows, with colored lights around a large center pane. The third section is the north side of the one-story rear section, and it has two smaller one-over-one-light double-hung vinyl window the gable, and another matching window in the rear section.

The south elevation is similarly divided into three sections. The right/east section is the side of the main section of the house and front bay window. There is no fenestration on this section. The center

section is the south gable-roof section, which extends somewhat to the south from the main form of the house. It has two one-over-one-light double-hung vinyl windows evenly spaced on the first story, with similar windows above them on the second story. The gable has a small vent. The third section is the south side of the rear one-story section, and it has a steel entry door with a window. It has a small wood stoop and steps down to a concrete walk. Immediately to the right of the side entry, there is a small one-over-one-light double-hung vinyl window.

The west elevation, the rear of the house, is partly obscured by a one story addition, a three seasons room, and the garage roof. The second story of the main two-story section of the house has has a oneover-one-light double-hung vinyl window on the right/south. The one-story rear section appears original, appearing on the first Sanborn map with this block in 1917. It has a hip roof covered with asphalt shingles, vinyl siding, and sits on a stone foundation. It has a one-over-one-light double-hung vinyl window with wood shutters on the left. There is a patio door on the right. There is a small hip-roof dormer at the center of the roof with a single-light vinyl window. A basement garage addition extends west from the rear section, with a driveway through the hill to W. Washington to the north. The assessor lists a construction date of 2001. The roof is flat and has a wood deck over the roofing material, with a vinyl railing around the perimeter. There are wood steps leading from the roof deck down into the yard. At the southwest corner of the one story rear section, and south of the garage/deck, there is a three seasons room clad in vinyl siding and has a gable roof covered with asphalt shingles. The south elevation has nine single-light vinyl casement windows, the east elevation has two single-light vinyl casement windows, the west elevation has six single-light vinyl casement windows, and the north elevation has six single-light vinyl casement windows. At the far left on the north side, a steel entry door leads to the garage roof deck.

#### Narrative Statement of Significance

The James A. and Amy Work House appears to contribute historically to the potential "west side" residential historic district in Washington. The construction of the Queen Anne house in 1895 was on a prominent site at the west end of W. Washington. The house was built for businessman James Work, owner of a boots and shoe store on the west side of the square. With the later designation of Sunset Park, the house became located on the south side of the entry into the park.

The house does not appear individually eligible for listing on the National Register of Historic Places under Criteria A, B, or C. The vinyl siding and replacement windows have impacted the integrity for individual listing.

#### History / research summary of property

A large portion of block 2 of the Southwest Addition to Washington was owned in the 1890s by Hiram and William Scofield, real estate investors and agents. On October 26, 1894, they sold part of lots 1 & 2 to James A. Work, described as "commencing at the northeast corner of Block 2, west 124 ft., then south 66 ft, then east 124 ft, then north 66 ft to beginning." Lots 1 and 2 were originally platted north-

south to face W. Washington, but this parceled the lots into east-west lots facing S. Avenue F to the east instead. A note in the Washington Press on October 31, 1894 says, "James Work will join the Gospel Ridge set ... He has bought the northeast part of the old 2<sup>nd</sup> U.P. Church grounds, on that high knoll made dry by the dry sermons preached there, and will build in the spring." On April 10, 1895, the Press reported, "The frame of Jim Work's new house is up on Gospel Knoll..." and later, in June 1895, the *Press* described the house, "Taking into account the situation and the style of the house, Jim Work has the prettiest place in town. Little towers and points are just the thing for a building on a hillside. Viewed from the street north, especially, it is very striking. We always coveted that building lot. Now some pretty color of paint and it will be perfect." James Work is listed in the 1894 city directory living at 608 N 2nd. He was partner in a shoe store on the west side of the square which advertised from 1895 through 1906. He was also twice elected Supreme President of the Home Guards of the World, a fraternal beneficiary society. The 1900 census lists the family as James A. Work, age 39, a shoe merchant, his wife Amy M., age 38, and daughters Florence, age 12, and Helen, age 8. The 1903 city directory lists J.A. Work, shoe dealer, wife Amy, and Helen, a student, at 701 W. Washington. By 1910, the census includes James A. Work, age 49, his wife Amy M., age 48, daughter Helen, age 18, and son James A. Jr., age 5. The 1910-11 city directory lists James A. Work (wife Amy M.) residing at 701 W Washington, with the shoe store at 107 S Marion. The property was sold to Matthew and Elizabeth Gillespie in February 1911, and the Work family apparently moved to Montana. The Evening Journal notes on October 30, 1911 that Mrs. J.A. Work, and son James Jr, would be visiting the home of Mr. and Mrs. Daniel Wilde. They later moved back to Washington and into the house to the south with Amy's mother Elizabeth Wilde.

James A. and Amy Work sold the house to Matthew and Elizabeth Gillespie on February 8, 1911. The 1917 county directory lists Matt Gillespie, retired, and his wife Elizabeth living at this address. The 1920 census lists Matthew and Elizabeth Gillespie living at 701 W. Washington. He is the owner of the house, age 80, while Mrs. Gillespie is age 60. By 1930, the census shows only Mrs. Gillespie, head of the household, age 69 and a widow. Her house is valued at \$3,500. The 1935 city directory lists her as Mrs. Mattie Gillespie, owner. In the 1940 census, she is still living at this address and is age 80. The following year, the city directory lists Mrs. Mattie Gillespie, widow, retired, and Miss Zoe Gillespie, housekeeper.

The Elizabeth J. Gillespie estate transferred interest in the property to Thomas & Wallace McCracken on January 11, 1944. It apparently transferred in family, and in September 1946, Zoe Gillespie sold the property to George C. Stewart. No city directories exist for the late 1940s to confirm if he lived here. In 1930, the census lists George C. Stewart, hardware and implement salesman, age 32, his wife Ruby M., age 31, and children Clinton, age 8, Roberta, age 7, and Henrietta, age 3, renting the house next door at 209 S. Ave. F. The 1941 city directory lists them as living in and owning the house at 421 S. Avenue B, and he was a salesman for Fred L. Stewart Hardware. They owned this house at 701 W. Washington St for five years.

George Stewart sold the property to Keith and Margaret Norton on September 27, 1951. Keith Norton is listed in the 1952 telephone book, at 701 W. Washington, and in subsequent directories through 1960. However, on August 2, 1955, Norton sold the property to Glenn L. and Florence Laffer. In the 1964 city directory, Glenn L. Laffer, retired, is listed as living at this address. Laffers continued to own the

property but apparently use it as a rental. By the 1967 city directory, the residents are Clifford R. and Verda Braun and sons Dennis and Daryl. He is working as a salesman for Yoder Feeds, and his wife is an employee at Advance Ross Electronics. In the 1969 city directory, he is a district representative for Full-O-Pep Feed with Allied Mills, and Verda is a secretary receptionist for Drs. Vosika, Montgomery, and Martens. Daryl is living at home, but Dennis is not listed here. The 1972 city directory identifies Rev. Leland Grove, pastor of the First Christian Church, his wife Jeanette, and their children Linda Kay, a student at the University of Iowa, and a son Marv at this address.


